



## **PNW District - Family Membership Program**

The Kiwanis PNW District will be participating in the Family Membership pilot project. This program will help reduce the costs of membership for both existing and new members – helping our clubs strengthen their membership. The program for the PNW went live on July 1, 2013.

### **Proposed Family Membership Structure:**

- Requires members to have the same primary address (shared residence) and be members in the same club.
- Allows a maximum of three members to join under the Family Membership option (full paying member and 2 discounted members).
- Family membership applies only to existing clubs. New clubs require a minimum of 15 full paying members to charter. Family members can be added after the charter has been given.
- College students where no Circle K International presence exists are eligible.

### **Fee Structure:**

- The first member of the family is charged:
  - Full New Member enrollment fee – for new members only
  - Full annual KI and District membership dues, insurance and magazine subscriptions.
- The second/third members of the family are charged:
  - 50% of New Member Enrollment Fee – for new members only.
  - 50% discount on annual KI and District membership dues.
  - 100% of insurance portion of membership dues.
- Club dues remain unchanged, unless the club elects to adopt a similar structure.
- Spousal credits will not apply. Only one magazine subscription per address

### **Club Requirements:**

The club will be responsible for verifying the legitimacy of the address/family connection. Kiwanis International will not police the roster for discrepancies. In the event the full paying member of the family terminates membership in the club, then one of the discounted members must begin paying full dues. The club must agree to pass the International and District 50% dues savings to the member and realize that this is a pilot program that may be terminated after the trial phase. We have the ability to determine the future of this program with our success – let's make it work.

### **Administrative Details:**

- Family Membership members have all the rights and privileges of full Kiwanis membership including, but not limited to, voting rights and right to hold office.
- Discounted Family Members will receive a new membership e-mail/gift offering, including free Kiwanis International convention registration for the first International convention attended. This is for new members only, not existing members who opt to participate.
- Discounted Family Memberships are non-transferable. No other discounts apply
- Qualified members must apply for acceptance to the Family Membership Program, prior to the October 1<sup>st</sup> billing date. Applications after that date will apply to the following year.

As this is a pilot program, we understand that changes to our club bylaws bylaw changes are not required at this time and, further, that the long term continuation of the program will be dependant on its success. Kiwanis International will review the program after the pilot phase to determine whether to continue with Family discounted memberships. *Both the club Board of Directors and our family members understand that Family Membership Status is not permanent at this time and that this program may be discontinued at any time.*
